DESCRIPTION

The land embraced in the annexed plat of Harmon City Heights a subdivision of part of Lot 3 of Sec. 13 T.20 N. R.7 E. Whitney Twp. Arenac County Mich. is described as follows: All that part of Lot 3 Sec. 13 of said town and range, lying east of the east line of U.S. 23 highway right of way, beginning at a monument on the south line of Lot 3 and on east line of right of way, being 468.37 ft. E. of SW Corner of Lot 3; then along E. line of right of way N 89° E. 631 ft. to 300 ft. W. S. E. 180 ft. N 1° E. 300 ft. to north line of Lot 3; then E. 313 ft. to the shore of Lake Huron; then S. 1° E. 400 ft. S. 2° W. 400 ft. S. 5° W. 522 ft. along the shore of Lake Huron to the south line of Lot 3; then West 392 ft. to point of Beginning.

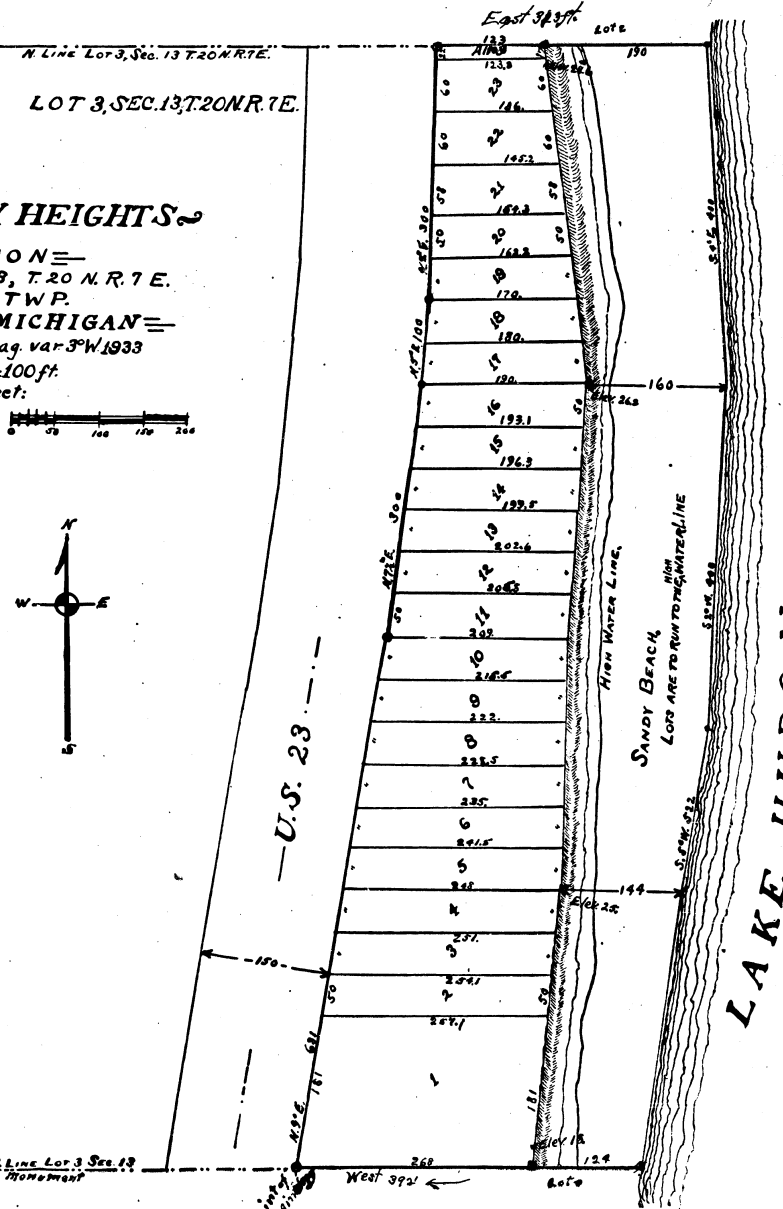
