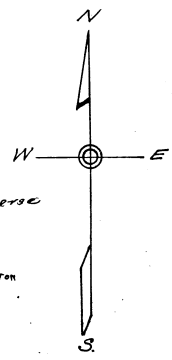


"CHAS. J. STURMAN'S SUB."

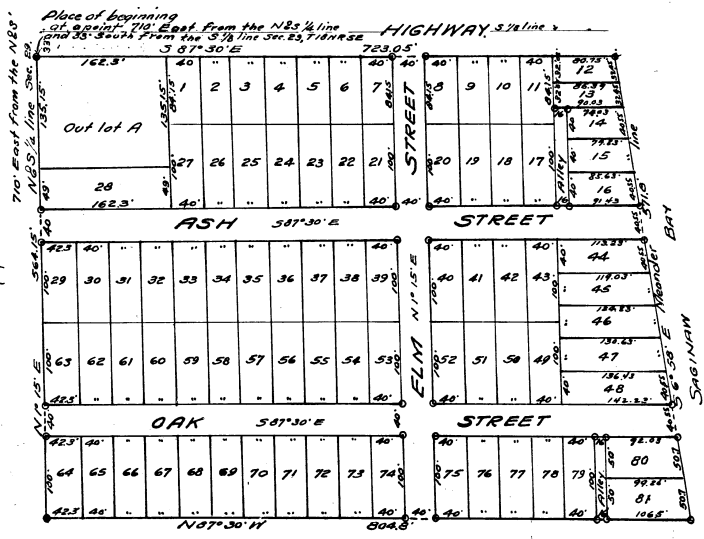
SURVEYOR'S CERTIFICATE.
