**Steps to follow if you plan to build any type of structure
(Includes HUD manufactured & State Approved f.k.a. "BOCA" homes)**

- 1) Local zoning (see below)
- 2) Sub Division Approval, if applicable (or Property Owner's Associations)
- 3) Health Dept. Permits &/or existing system evaluations (septic and/or well)
- 4) Soil Erosion & Sediment Control, if applicable (is project within 500 ft of any waterway of the State of Michigan or disturbing more than acre of soil?)
- 5) Driveway Permit, Arenac County Road Commission 989-718-3250
- 6) Building Permit including consulting the Michigan Uniform Energy Code **PRINTS**
- 7) Electrical, Mechanical & Plumbing Permits

**Always check with your inspectors to see if permits are required for the work you plan to do.
