

Canvass of the November 4, 2014 General Election in Arenac County:

Chair Gail Schmidt called the meeting of the Arenac County Board of County Canvassers to order at 1:00 PM on Wednesday, November 5th, 2014 pursuant to Public Notice and the Michigan Open Meetings Act.

Present: Members: Gail Schmidt, Ardith Fales, Keith Rebischke, JoEllyn Pedota.
Also Present: County Clerk Rick Rockwell, Acting Secretary.

The Board reviewed the summary sheets prepared from election night, each member was given a listing of write in candidates and it was agreed that in order to assist neighboring Counties of Iosco and Ogemaw with respective school elections, we would proceed with the canvass of Clayton, Mason and Whitney Townships first.

Whitney Township:

The Poll Book and Tabulator tape read that four hundred fifty-two(452) voters cast ballots and all numbers matched the sheets prepared, and that Robert G. Boensch, write in candidate for US Senate received one (1) write in vote. There were no other write in votes recorded in Whitney Township. Treasurer candidate received votes as listed in summary. All entries were recorded properly and sheets reflect voted totals. This concludes the canvass of Whitney Township. Board directed Clerk to prepare a partial canvass report to submit to Iosco County Board of County Canvassers.

Clayton Township:

The Poll Book and Tabulator tape read that Two hundred eighty-six (286) voters cast ballots and all numbers matched the sheets prepared and that the following received write-in votes: Arenac Eastern School Board: Ann Brown one (1) vote. Standish-Sterling School Board: Dennis Haut received three (3) votes; Shawna Johnson received six (6) votes. Whittemore-Precott Area School Board: The following received votes as listed in summary: Lyndsey Hennard received three (3) votes; Dean Horn received eleven (11) votes; and Lynn Mervin received one (1) vote. This concludes the canvass of votes in Clayton Township. Board directed Clerk to prepare a partial canvass report for Whittemore-Prescott School Board as well as the millage issue numbers as listed in the summary report and to forward said totals along with Mason Township totals to the Ogemaw County Clerk. This concludes the canvass of the votes in Clayton Township.

Mason Township:

The Poll Book and Tabulator tape reflected that two hundred twenty-two (222) voters cast ballots and all numbers matched the sheets prepared, and that the following received write-in votes: Arenac Eastern School Board: Ann Brown received four (4) votes; Whittemore-Prescott Area Schools: Lyndsey Hennard received -0- votes; Dean Horn received seven (7) votes, and Lynn Mervin received two (2) votes. This concludes the canvass of the votes for Mason Township. The Board directed the Clerk to combine school board totals and forward Whittemore-Prescott totals, including millage results, to the Ogemaw County Board of Canvassers.

Page # 2: Canvass of the November 4, 2014 Arenac County General Election:

Au Gres City:

The Poll Book and Tabulator tape totals reflected that three hundred fifty-six (356) voters cast ballots and all numbers matched the sheets, and that the following candidates received write-in votes: Au Gres-Sims School Board: Jeffrey Taylor received sic (6) votes. This concludes the Canvass of the City of Au Gres.

Arenac Township:

The Poll Book and Tabulator tape totals reflected that two hundred ninety-three (293) voters cast ballots and all numbers matched the sheets prepared and that the following candidates received write-in votes: Arenac Eastern School Board: Ann Brown received thirteen (13) votes. Standish-Sterling School Board: Dennis Haut received one (1) vote; Shawna Johnson received four (4) votes. This concludes the canvass of the Township of Arenac.

City of Standish:

The Poll Book and Tabulator tape totals reflected that three hundred fifty-six voters cast ballots and all number matched and the sheets prepared and that the following write-in candidates received votes as listed: Standish-Sterling School Board: Shawna Johnson received eleven (11) votes; Dennis Haut received three (3) votes. There were no other write in votes. This concludes the canvass of the City of Standish.

Au Gres Township:

The Poll Book and Tabulator tape totals reflected that three hundred and fifty six (356) voters cast ballots and all numbers matched the sheets prepared and that the following write-in candidates received votes: Au Gres-Sims School Board: Jeffrey Taylor received two (2) votes. There were no other write-ins and this concludes the canvass of the Township of Au Gres.

Recess of Canvass:

It was agreed, that the canvassers would recess until 10 AM tomorrow to allow the Clerk to attend another meeting and it was moved by JoEllyn Pedota and seconded by Ardit Fales to recess until Thursday, November 6th at 10 AM in the Clerk's Office to move to a location to be determined to continue the Canvass of the Votes of the November 4th, 2014 General Election. Motion carried and the meeting was recessed.

Chair Gail Schmidt called the meeting of the Arenac County Board of County Canvassers for the Canvass of Votes in the November 4, 2014 General Election back to order to continue the canvass of the election. It is noted that all members mentioned the prior day were in attendance, being Ardit Fales, Keith Reischke, JoEllyn Pedota, and Gail Schmidt and the County Clerk, Ricky R. Rockwell acting as secretary for the

Page # 3: Canvass of the November 4, 2014 General Election in Arenac County:

Deep River Township:

The Poll Book and Tabulator tape totals reflected that seven hundred two (702) voters cast ballots and all numbers matched the sheets prepared. It was noted that no zero tape was furnished and that both tapes lacked this. In addition, the Tabulator ribbons were almost illegible. The following write-in candidates received votes: Standish-Sterling School Board: Dennis Haut received twenty-two (22) votes; Shawna Johnson received twenty-eight (28) votes. There were no other write-ins. The Township Road proposal received totals as listed and passed. This concludes the canvass of votes in Deep River Township.

Turner Township:

The Poll Book and Tabulator tape totals reflected that 181 voters cast ballots and all numbers matched the sheets as prepared. The zero tape was NOT attached to either tape presented to the Clerk and Canvassers however. Envelopes were sealed by the sticky tape on them was NOT removed from the envelopes. The following write-in candidates received votes: Arenac Eastern School Board: Ann Brown received nine (9) votes. Clerk candidate and Treasurer candidate received votes as listed in summary. This concludes the Canvass of votes in Turner Township.

Omer City:

The Poll Book and Tabulator tape totals are off one vote, which is explained in that the notes present that one provisional ballot was issued a voter. The Canvassers have received from the Clerk that she has notified the voter involved that they are not a registered voter in the City and the voter cannot supply any proof of such and that the ballot will NOT be tabulated. This means that 87 voters presented themselves in the Poll Book and that 86 votes were tabulated. The election workers did not provide a zero tape to the Canvassers or Clerk. The following candidates received write-in votes: Arenac Eastern School Board: Ann Brown received twelve (12) votes. This concludes the Canvass of votes in Omer City.

Adams Township:

The Poll Book reflected that one hundred eighty (180) voters cast ballots and all numbers matched. The following candidates received write-in votes: Standish-Sterling School Board: Shawna Johnson received nine (9) votes; Dennis Haut received eight (8) votes. There were no other write-ins. Unopposed township trustee vacancy candidate received votes as listed in summary. Canvassers noted that tally sheets were not totaled at the end of the Columns. This concludes the canvass of votes in Adams Township.

Sims Township:

The Poll Book and Tabulator tape reflected that four hundred eighty-four (484) voters cast ballots and that all numbers matched the sheets as prepared. All other numbers from the tape matched spread sheets as prepared and attached. There were no write-in votes recorded. This concludes the canvass of votes from the Township of Sims.

Page # 4: Canvass of the November 4, 2014 General Election in Arenac County:

Moffatt Township:

The Poll Book and Tabulator tape reflected that five hundred eight (508) voters cast ballots and further reflected that same number were tabulated. The following persons received write-in votes for the following offices: Governor: Richard Allen Sills one (1) vote. U. S. Senator: Jeff Jones received one (1) vote. There were no other write-in votes recorded by election workers. This concludes the canvass of votes in Moffatt Township.

Lincoln Township:

The Poll Book and Tabulator tape reflected that two hundred eighty-three (283) voters cast ballots and further reflected that same number were tabulated. The following person received write-in votes: Standish-Sterling School Board: Shawna Johnson received twenty-four (24) votes and Dennis Haut received two (2) votes. There were no other write-in votes. This concluded the canvass of votes from the Township of Lincoln.

Standish Township:

The Poll Book and Tabulator tape reflected that six hundred forty (640) voters cast ballots and further reflected that same number was tabulated. The following persons received write-in votes: Shawna Johnson received nineteen (19) votes and Dennis Haut received eight (8) votes. There were no other write-ins recorded. This concludes the canvass of votes in Standish Township.

Receipt of Standish-Sterling Vote Totals:

Gladwin County: The County Clerk noted to canvassers that no Standish-Sterling School District voters cast ballots and there were no votes to tally for the election for School Board.

Bay County: The County Clerk reported that the election night totals of ballots from Pinconning Township and Gibson Township are as follows;
