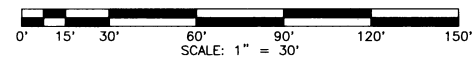


AMENDED PLAT OF LOTS 13 AND 14, BLOCK 4 OF WELLE'S ADDITION TO VILLAGE OF STANDISH

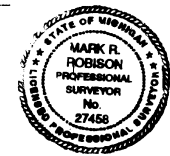
SURVEYOR'S CERTIFICATE

I, MARK R. ROBISON, SURVEYOR, CERTIFY THAT I HAVE SURVEYED, DIVIDED, AND MAPPED THE LANDS SHOWN ON THE PLAT DESCRIBED AS FOLLOWS: AMENDED PLAT OF LOTS 13 AND 14, BLOCK 4 OF WELLE'S ADDITION TO THE VILLAGE OF STANDISH, PART OF THE NORTHWEST ONE-QUARTER, SECTION 12, T18N, R4E, STANDISH TOWNSHIP, ARENAC COUNTY, STATE OF MICHIGAN, DESCRIBED AS: BEGINNING S 89° 16' 16" E, ALONG THE NORTH SECTION LINE, 660.00 FEET AND S 00° 44' 53" W, ALONG THE CENTER LINE OF PIERSON AVENUE, WELLE'S ADDITION TO THE VILLAGE OF STANDISH, AS RECORDED IN SLIDE 1 OF PLATS OF PAGE 9, ARENAC COUNTY, MICHIGAN PUBLIC RECORDS, 362.70 FEET FROM THE NORTHWEST CORNER OF SECTION 12, T18N, R4E, STANDISH TOWNSHIP, ARENAC COUNTY, STATE OF MICHIGAN; THENCE CONTINUING S 00° 44' 53" W, ALONG SAID CENTER LINE OF PIERSON AVENUE, 131.88 FEET TO THE NORTH LINE OF SECOND STREET; THENCE N 89° 13' 13" W, ALONG SAID NORTH LINE OF SECOND STREET, 156.73 FEET TO THE SOUTHWEST CORNER OF LOT 14, BLOCK 4, SAID WELLE'S ADDITION TO THE VILLAGE OF STANDISH; THENCE N 00° 44' 43" E, ALONG THE WEST LINE OF LOTS 13 AND 14, SAID BLOCK 4, 131.84 FEET TO THE NORTHWEST CORNER OF SAID LOT 13; THENCE S 89° 14' 06" E, ALONG THE NORTH LINE OF SAID LOT 13 AND SAID NORTH LINE EXTENDED, 156.73 FEET BACK TO THE PLACE OF BEGINNING. CONTAINING TWO LOTS AND 0.5 ACRE.

THAT I HAVE MADE SUCH SURVEY, LAND DIVISION AND PLAT BY THE DIRECTION OF THE OWNERS OF SUCH LAND. 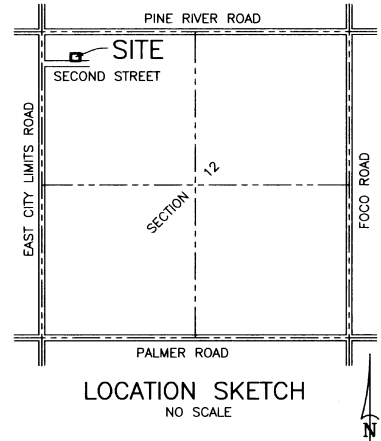

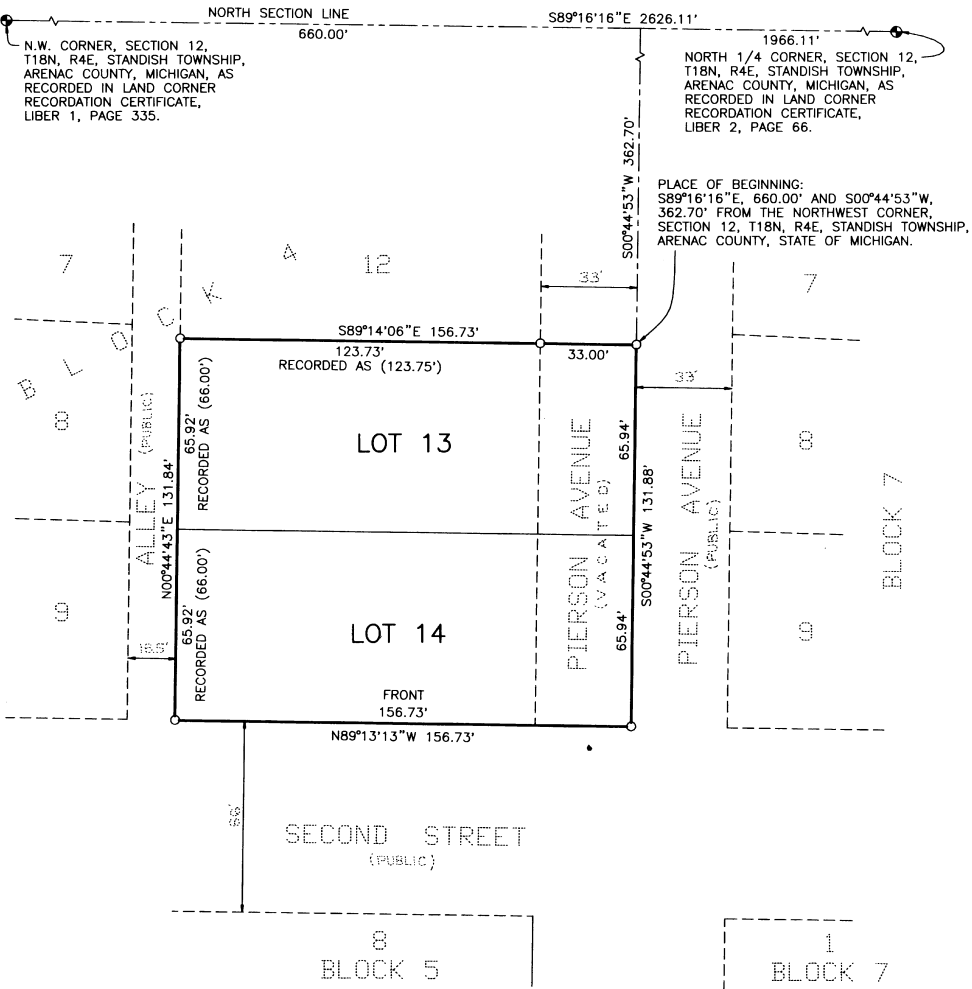
