## **Scope of Work:**

Removal of Approximately 35 Trees:

- Trees will be marked by Owner prior to cutting. Selected Contractor must perform a site walk with Owner or Owner Representative prior to cutting trees.
- Stumps are to be left in place. Trees must be cut a minimum of 3 feet from the ground surface
- Tree Disposal
  - o Haul entire tree (trunk and limbs) off site.
    - Or
  - Limbs and branches can be removed from trunk and hauled to and placed on the burn pile located on the FLPOA property near the campgrounds. No wood chips can be placed in the burn pile
  - And limb free trunk cut into a maximum 10 feet log and hauled to the FLPOA property located east of S. Forest Lake Drive, South of Bear Cub Lane. Logs are to be neatly stacked


