# Minutes of the 2011 Organizational Session Arenac County Board of County Commissioners January 4, 2011

County Clerk Ricky R. Rockwell called the meeting to order at 9:58 AM pursuant to call from the County Clerk with the following Commissioners in attendance: Joseph Sancimino, Virginia Zygiel, Michael Snyder, Robert A. Luce, and Jeff Trombley.

The meeting opened with the Board reciting the Pledge of Allegiance to the US Flag as well as those others in attendance.

The Clerk requested Public Comment from anyone in attendance:

Dennis Stawowy, Arenac County Treasurer, commented on the certain issues regarding Board, reports, and related County business issues.

JoEllyn Pedota, Standish Township Resident, wished the Board well as well as her new Commissioner, Mr. Trombley.

Sharon Belchak, Standish Township Resident, likewise wished the board well as well as her new Commissioner, Mr. Trombley.

There were no further public comments.

The Clerk then proceeded on with the conduct of the meeting. Noting that the first issue to be resolved is whether or not the Board wishes to organize for either ONE or TWO years for the election of a Chair and Vice Chair.



#### RESOLUTION FOR THE DEPOSIT AND INVESTMENT OF ARENAC COUNTY FUNDS

WHEREAS, under the laws of the State of Michigan, Act No. 40 of the Michigan Public Acts of 1932, 1<sup>st</sup> Extra Session, as amended (MCL 129.12), this Board is required to provide, by resolution, for the deposit of all public monies including tax monies, belonging to, or held for, the State, County, or other political units coming into the hands of the County Treasurer, in one or more banks, savings and loan associations, or credit unions within the State.

THEREFORE BE IT RESOLVED, (1) The Arenac County Board of Commissioners hereby directs Dennis M. Stawowy, Arenac County Treasurer, to deposit all public monies and funds coming into his hands as County Treasurer in any bank, savings and loan association, or credit union within the State which is a legal depository as defined by State and/or Federal law, and (2) the County Treasurer is authorized to invest funds, as set forth by the Arenac County Investment Policy, with these institutions or any institution legally permitted by State Statute, Act No. 20 of the Michigan Public Acts of 1943, as amended (MCL 129.91), or Federal law or regulation within the limits set therein.

THEREFORE BE IT RESOLVED, that the County Treasurer is authorized to enter into and execute on behalf of the County any contracts with any bank or trust company for the safekeeping or third party custodianship of any of the County's securities as well as any contracts or repurchase agreements with any corporation for the purchase of any such securities which will be the subject of such safekeeping or third party custodianship arrangements, on such terms and conditions as the County Treasurer shall require.

BE IT FURTHER RESOLVED, that the County Treasurer is authorized to rely on the continuation of this resolution until amended or replaced by a subsequent resolution of this or successor Board of Commissioners.

## 2011 INVESTMENT POLICY FOR THE COUNTY OF ARENAC

As Required by Public Act 20 of 1943, as amended

#### 1.0 PURPOSE

The deposits and investments of state and local governments are exposed to risks that have the potential to result in losses. It is the policy of Arenac County to invest public funds in a manner which will ensure the preservation of principal while providing the highest investment return with maximum security, meeting the daily cash flow requirements of the County and conforming to all State statutes by addressing common deposit and investment risks related to credit risk, concentration of credit risk, and interest rate risk.

#### 2.0 SCOPE

This investment policy applies to all financial assets of the County. These assets are accounted for in various funds of the County and include the general fund, special revenue funds, capital project funds, enterprise funds, internal service funds, trust and agency funds, and any new fund established.

#### 3.0 OBJECTIVE

Arenac County's primary objectives, in priority order are safety, minimized risk, liquidity, and return on investments, with the foremost objective of this policy being safety of principal funds. Investment transactions undertaken by the County Treasurer will be conducted in a manner to ensure the preservation of capital in the overall portfolio. The objective will minimize credit risk and interest rate risk.

- 3.1 Safety: Safety of principal is the foremost objective in the investment of county funds. Investments shall be undertaken in a manner that seeks to ensure the preservation of principal in the overall portfolio. To attain this objective, diversification is required in order that potential losses on individual securities do not exceed the income generated from the remainder of the portfolio.
- 3.2 Credit Risk: (Custodial Risk and Concentration on Credit Risk) The County will minimize Custodial Credit Risk, which is the risk of loss due to the failure of the security issue, or backer, by limiting investments to the types of securities listed in Section 6.0 of this policy, and prequalifying the financial institutions, broker/dealers, intermediaries and advisors with which the County will do business in accordance with the policy. The County will minimize Contraction of Credit Risk, which is the risk of loss attributed to the magnitude of the County's investment in a single issuer, by diversifying the investment portfolio so that the impact of potential losses from any one type of security or issuer will be minimized.
- 3.3 Investment Rate Risk: The County will minimize Interest Rate Risk, which is the risk that value of securities in the portfolio will fall due to changes in the market interest rates by: structuring investment portfolio so

that securities mature to meet cash requirements for ongoing operations, thereby avoiding the need to sell securities in the open market; and investing operating funds primarily in shorter-term securities, liquid asset funds, money market mutual funds, or similar investment pools and limiting the average maturity in accordance with the County's known cash requirements.

- 3.4 Foreign Currency Risk: The County is not authorized to invest in investments which have this type of risk.
- 3.5 **Liquidity:** The investment portfolio shall remain sufficiently liquid to enable the County Treasurer to meet all operating requirements which might be reasonably anticipated.
- 3.6 **Return on Investments:** The investment portfolio shall be designed with objective of attaining a return throughout budgetary and economic cycles, commensurate with the investment risk constraints and the cash flow characteristics of the portfolio.

#### 4.0 DIVERSIFICATION

The County Treasurer shall diversify his/her investments by security type and institution. With the exception of U.S. Treasury securities and authorized investment pools, no more than 60% of the local investment portfolio will be invested in a single security type and no more than 60% of the portfolio with a single financial institution.

#### 5.0 DELEGATION OF AUTHORITY

Attached here, as Appendix #1; is the Arenac County Board of Commissioner's depository and investment resolution as required by the State statute (P.A. 40 of 1932 and MCL 129.12). Management responsibility for the investment policy is hereby delegated to the County Treasurer.

#### 6.0 AUTHORIZED INVESTMENTS

The County Treasurer is authorized to invest in the following types of securities authorized by Public Act 20 of 1943, as amended;

- 6.1 Bonds, securities, and other obligations of the United States or an agency or instrumentality of the United States.
- 6.2 Certificates of Deposit, savings accounts, deposit accounts, or depository receipts of a financial institution.
- 6.3 Commercial Paper rated at the time of purchase within the two highest classifications established by not less than two standard rating services and that matures not more than 270 days after the date of purchase.
- 6.4 Repurchase agreements consisting of instruments in subdivision 6.1.
- 6.5 Bankers' acceptances of United States banks.
- 6.6 Obligations of this State of any of its political subdivisions that at the time of purchase are rated as investment grade by not less than 1 standard rating service.
- 6.7 Investment pools organized under the surplus funds investment pool act, 1982 PA 367, MCL 129.111 to 129.118.

- 6.8 Investment pools organized under the local government investment pool act, 1985 PA 121, MCL 129.141 to 129.150.
- 6.9 Obligations described in subdivisions (A) thru (G) of PA 20, as amended in 1997, if purchased through an inter-local agreement under the "Urban Cooperation Act of 1967", 1967 (Ex. Sess.), PA 7, MCL 124.501 to 124.512.
- 6.10 Mutual funds registered under the investment company act of 1940, title 1 of chapter 686.54 Stat. 789, 15 U.S.C. 80a-1 to 80a-3 and 80a-4 to 80a-64, with the authority to purchase only investment vehicles that are legal for direct investment by the County. This authorization is limited to securities whose intention is to maintain a net asset value of \$1.00 per share.

### 7.0 SAFEKEEPING AND CUSTODY

It shall be the responsibility of the County Treasurer to determine which securities will be held by a third party custodian & shall be evidenced by a safekeeping receipt.

#### 8.0 PRUDENCE

The standard of prudence to be used by the County Treasurer shall be the "prudent person" standard and shall be applied in the context of managing an overall portfolio. Investments shall be made with judgment and care, under circumstances then prevailing, which persons of prudence, discretion and intelligence exercise in the management of their own affairs, not for speculation, but for investment, considering the probable safety of their capital as well as the probable income to be derived.

### 9.0 REPORTING

The County Treasurer shall provide at least an annual report to the Board of Commissioners, which provides a clear picture of the status and types of investments in the current investment portfolio. This report shall be prepared in a manner, which will allow the Board of Commissioners to ascertain whether investment activities during the reporting period have conformed to the investment policy.

## 10.0 AGREEMENT TO COMPLY

Before executing an order to purchase or trade the funds of the County of Arenac, a financial intermediary, broker or dealer shall be provided with, and acknowledge receipt of, the County's "Investment Policy" regarding the buying or selling of securities by executing the form attached here as Appendix #2.

## 11.0 POLICY CONSIDERATIONS

This policy shall be reviewed periodically and amended to reflect changes in State statutes or the needs of Arenac County.

Whereas, in 2005-06, there were 45 Michigan children who died as a result of abuse, 44% who were between the ages of 1-4, and 49% of these children were under 1 year of age and;

Whereas, in 2005-06, there were 38 child neglect death cases, 13 percent were children between the ages of 1-4, and 63 percent were children younger than 1 year of age and;

Whereas, abused or neglected children have a higher risk in adulthood for developing health problems, including alcoholism, depression, drug abuse, eating disorders, obesity, suicide, and certain chronic diseases and;

Whereas, a National Institute of Justice study indicated that abused or neglected children-

- (1) are 11 times more likely to be arrested for criminal behavior as juveniles and;
- (2) are 2.7 times more likely to be arrested for violent and criminal behavior as adults and;
- (3) Whereas, an estimated 1/3 of abused or neglected children grow up to abuse or neglect their own children and;

Whereas research has proven the success of quality home visitation, parenting-coaching and family support programs that prevent children from being abused or neglected, reduce subsequent delinquency, and improve other outcomes for children-including home visiting models like the Michigan Zero-to-3 Secondary Prevention Initiative, the Nurse-Family Partnership, Healthy Families, Early Head Start, and Parents as Teachers and;

Whereas, providing community-based services to families at-risk or already impacted by child abuse or neglect may be far less costly than—

- (1) the emotional and physical damage inflicted on children who have been abused or neglected and;
- (2) providing the abused or neglected children services, including child protective, law enforcement, court, foster care, or health care services and; or
- (3) providing treatment to adults recovering from child abuse and; or
- (4) providing incarceration to convicted criminals of child abuse and neglect and;

Whereas, child abuse or neglect has long-term economic and societal costs,

Now, therefore, be it Resolved, That the Arenac County Board of Commissioners-

- (1) designates April 2011 as 'Child Abuser Prevention Month and;
- (2) recognizes and applauds the national, state, and community organizations and their skilled employees that work to promote awareness about child abuse or neglect, including by identifying risk factors and developing prevention strategies and;
- (3) supports the proclamations issued on the state and federal levels declaring April 2011 as 'Michigan Child Abuse Prevention Month' and 'National Child Abuse Prevention Month' and
- (4) should-
  - (A) increase public awareness of prevention programs relating to child abuse or neglect and;

(B) continue to work with the state- and federal- level agencies to reduce the incidence of child abuse or neglect in our community, state, and nation.



WHEREAS, the number of Michigan Seniors age 60+ is rising by 135 residents per day.

WHEREAS, state funding for aging services has decreased 28% over the past three years while Michigan's senior population has grown 7%.

WHEREAS, a disproportionate share of the State of Michigan's long term care budget (83%) is targeted to nursing facility funding;

WHEREAS, the Aging Network provides in-home support services and meals for \$4.72 per person per day;

WHEREAS, a majority of Michigan residents express a desire to remain in their homes for as long as possible;

WHEREAS, OSA services are an important support for unpaid caregivers who are providing 80% of the assistance that frail elders receive;

WHEREAS, the MI Choice Program provides a cost-effective alternative to nursing home care at an average of \$48 a day compared with an average cost of \$185 day for institutional care;

WHEREAS, a study done by Indiana University shows a s\$10 million increase in MI Choice brings an additional \$27 million in federal matching funds, creating 1.100 new jobs and returns \$1.9 million in tax revenues to the state yet funding is capped at \$206 million;

WHEREAS, the current waiting list for MI Choice Waiver enrollment is 6,700 statewide;

WHEREAS, some 13,300 older adult volunteers contributed 3.560,000 hours of service to 2,625 public and noon-profit organizations in Michigan in FY 2010 with an economic value of nearly \$750 million-a return of \$62 for every federal/state dollar expended;

WHEREAS, the proposed overhaul of Michigan's personal income tax disproportionately affects seniors and the poor in a negative manner.

#### Section 2: Establishment

The County Board hereby confirms the establishment under the Arenac County Planning Commission formally established under County Planning Act, Public Act 282 of 1945 MCL 125.103 et seq. The Arenac County Planning Commission shall have 7 members. Members of the Arenac County Planning Commission as the effective date of this Ordinance shall, except for an ex officio member whose remaining term on the Planning Commission shall be limited to his or her term on the County Board, shall continue to serve for the remainder of their existing terms so long as they to meet all the eligibility requirements for Planning Commission membership set forth within the Michigan Planning Enabling Act, Public Act 33 of 2008, MCL 125.3801, et seq.

## Section 3: Appointments and Terms

The Chairperson of the County Board, with the approval of the County Board of Commissioners, by a majority vote of members elected and serving, shall appoint all Planning Commission members, including the ex officio member. The Planning Commission members, other than ex officio, member shall serve for terms of three (3) years each.

A Planning Commission member shall hold office until his or her successor is appointed. Vacancies shall be filled for the unexpired term in the same manner as the original appointment. Planning Commission members shall be qualified electors of the county, except that one Planning Commission member may be an individual wh00 is not a qualified elector of the county. The membership of the Planning Commission shall be representative of the important segments of the county, such as economic, educational and social development of the county, in accordance with education, pubic health, government, transportation, industry, and commerce. The membership shall also be representative of the entire geography of the county to the extent possible. One (1) member of the County Board shall be appointed to the Planning Commission as an ex officio member. An ex officio member shall have full voting rights. An ex officio member's term on the Planning Commission shall expire with his or her term on the county board. No other elected officer or employee of the county is eligible to be a member of the Planning Commission.

#### Section 4: Removal


The County Board of Commissions may remove a member of the Planning Commission for misfeasance, malfeasance, or nonfeasance in the office upon written charges and after a public hearing.

#### **Section 5: Compensation**

The Planning Commission members may be compensated for their services as provided by County Board resolution. The Planning Commission may adopt bylaws relative to compensation and expenses of its members for travel when engaged in the performance of activities authorized by the County Board, including, but not limited to, attendance at conferences, workshops, educational and training programs, and meetings.

## Section 6: Officers and Committees

The Planning Commission shall elect a chairperson and a secretary from its members, and may create and fill other officers as it considers advisable. An ex officio member of the Planning Commission is not eligible to serve as chairperson. The term of each office shall be for one (1)



year, with opportunity for reelection as specified by the Planning Commission bylaws. The planning commission may also appoint advisory committees whose members are not members of the Planning Commission.

Section 7: Bylaws, Meetings and Records

The Planning Commission shall adopt bylaws for the transaction of business. The Planning Commission shall hold at least four (4) regular meetings each year and shall by resolution determine the time and place of the meetings. Unless otherwise provided in the Planning Commission's bylaws, a special meeting of the Planning Commission may be called by the Chairperson or by two (2) other members, upon written request to the secretary. Unless the bylaws otherwise provide, the Secretary shall send written notice of a special meeting to Planning Commission members at least forty-eight (48) hours before the meeting. The business that the Planning Commission may perform shall be conducted at a public meeting held in compliance with the Open Meetings Act, Public Act 267 of 1976, MCL 15.261, et seq. The Planning Commission shall keep record of its resolutions, transactions, findings and determinations. A writing prepared, owned, used, in the possession of, or retained by a Planning Commission in performance of an official function shall be made available to the public in compliance with the Freedom of Information Act, Public Act 442 of 1976, MCL 15.231, et seq.

Section 8: Annual Report

The Planning Commission shall make an annual report to the County Board concerning its operations and status of the planning activities, including recommendations regarding actions by the County Board related to planning and development.

Section 9: Authority to Make Master Plan

Under the authority of the Michigan Planning Enabling Act, Public Act 33 of 2008, MCL 125.3801, et seq. and other applicable planning statutes, the Planning Commission shall make a master plan as a guide for development within the County's planning jurisdiction. Final authority to approve a Master Plan or any amendments thereto shall rest with the Planning Commission unless the County Board passes a resolution asserting the right to approve or reject the Master Plan. Unless rescinded by the County, any plan adopted or amended under the County Planning Act, Public Act 282 of 1945 MCL 125.103, et seq., need not be readopted under the Michigan Planning Enabling Act, Public Act 33 of 2008, MCL 125.3801 et seq.

**Section 10: Zoning Powers** 

The County Board hereby confirms the transfer of all powers, duties, and responsibilities provided for zoning boards or zoning commissions by the former County Rural Zoning Act, Public Act 110 of 2006, MCL 125.31, et seq.; the Zoning Enabling Act, Public Act 110 of 2006, MCL 125.31, et seq.; or other applicable zoning statutes to the Arenac County Planning Commission formally established under the County Planning Act, Public Act 282 of 1945 MCL 125.103, et seq. Any existing zoning ordinances shall remain in full force and effect except as otherwise amended or repealed by the County Board.

Section 11: Capital Improvements Plan

To further the desirable future development of the county under the Master Plan, the County Board, after the Master Plan is adopted, shall prepare or cause to be prepared by the County

Chair or by a designated nonelected administrative official, a capital improvements program of public structures and improvements, showing those structures and improvements in general order of their priority, for the following 6-year period. The prepared capital improvements program, if prepared by someone other than the County Board, shall be subject to final approval by the County Board. The County Planning Commission is hereby exempted from preparing a capital improvements plan.

## Section 12: Subdivision and Land Division Recommendation

The Planning Commission may recommend to the County Board provisions of an ordinance or rules governing the subdivision of land. Before recommending such an ordinance or rule, the Planning Commission shall hold a public hearing on the proposed ordinance or rule the Planning Commission shall give notice of the time and place of the public hearing not less than 15 days before the hearing by publication in a newspaper of general circulation within the county. The Planning Commission shall review and make recommendations on a proposed plat before action thereon by the County Board under the Land Division Act, Public Act 288 of 1967, MCL 560.101, et seq. Before makings its recommendation, the Planning Commission shall hold a public hearing on the proposed plat. A plat submitted to the Planning Commission shall contain the name and address of the proprietor or other person to whom the notice of a hearing shall be sent. Not less than 15 days before the hearing, notice of the date, time and place of the hearing shall be sent to that person at the address by mail and shall be published in a newspaper of general circulation in the County. Similar notice shall be mailed to the owners of land immediately adjoining the proposed platted land.

## Section 13: Severability

The provisions of this ordinance are hereby declared to be severable, and if any part is declared invalid for any reason by a court of competent jurisdiction, it shall not affect the remainder of the ordinance, which shall continue in full force and effect.

## Section 14: Repeal

All ordinances or parts of ordinances in conflict with this ordinance are hereby repealed. The resolution or ordinance establishing the Arenac County Planning Commission under County Planning Act, Public Act 282 of 1945 MCL 125.103, et seq. is hereby repealed.

#### Section 15: Effective Date

This ordinance shall take effect on the date of its publication.

WHEREAS, the long running restrictions in Northeast Michigan with heavy depopulating of whitetail deer on State and Federal lands have given us poor numbers of deer on these lands, while private lands are still high; and

WHEREAS, Hunter's numbers and demand for hunting land have declined dramatically under the current program, yet we still have the same prevalence rates on private land as we did 12 years ago; and

WHEREAS, food plots are legal and baiting is not, food plots still allow nose to nose contact;





LET IT BE KNOWN TO ALL PERSONS, that it is the policy of Arenac County through the Arenac County Housing Commission, to implement programs to ensure equal opportunity in housing for all persons regardless of religion, race, color, national origin, age, sex, height, weight, familial status, or marital status.

**THEREFORE,** Arenac County and the Arenac County Housing Commission does hereby pass the following resolution:

**BE IT RESOLVED THAT** Arenac County through the Arenac County Housing Commission, shall not discriminate in the sale, rental, leasing, or financing of housing because of religion, race, color, gender, physical or mental disabilities, national origin, age, height, weight, familial status, or marital status:

Arenac County through the Arenac County Housing Commission will assist all persons who feel they have been discriminated against because of religion, race, color, gender, physical or mental disabilities, national origin, age, height, weight, familial status or marital status, to seek equity under federal and state laws, by providing information to said persons on how to file a complaint with the Michigan Department of Civil Rights.

Arenac County through the Arenac County Housing Commission will at a minimum post this policy or the Fair Housing poster or other posters, flyers or other information which will bring to the attention of owners of real estate, developers and builders, their respective responsibilities and rights under the Federal Fair Housing Law and Michigan Elliott-Larsen Act.

This Resolution shall take effect as of the date listed below.



Arenac County Commissioners <u>Fiscal Responsibilities</u>
The monitoring of Arenac County public monies is a responsibility and obligation of all publically elected officials of the County. The Commissioners are specifically part of this obligation as noted in the 2011 County audit report.
The monitoring of the County finances consists of actually, and physically, reviewing of the financial records. Each Commissioner is to be assigned a specific set of records which will be monitored and reviewed on a regular basis. The result of these reviews will be part of the financial discussion of the regularly scheduled Commission meetings.
The funds to be monitored by the Commissioners are as follows:
Expenditures and Receipts: This is generally called the book of bills and the "on demand checks". All expenses and bills are to be supported by the appropriate documentation. The review includes the before and after monitoring of all expenditures of this type. These accounts are to be presented to the Board of Commissioners for their approval. These bills are to be submitted, for payment, at a regular meeting of the Commission.
Accounts Payable: Checks are to be supported by proper documentation. This includes time-cards, time sheets, and actual payment amounts, also corresponding documentation relating to computation of amounts. Cancelled and received checks are to be justified with monthly statements from the appropriate Bank and vender inducements checked.
Electronic Transfer Transactions: The transfer of any monies, in or out, of the county, electronically, must contain the proper documentation and be justified with the appropriate deposit or vendor receipt. Included will be all revenues, checks and receipts, including investments.
The monitoring of these, and other accounts, is essential for the development and trust of the Counties constituents. A committed and dedicated accounting of the public's monies reflects on all those "Elected to serve".

### ARENAC COUNTY FUND BALANCE POLICY

### **Purpose**

To establish an appropriate level of fund balance in the General Fund, define the components of fund balance, and direct officials in the methods to be used for increasing and decreasing fund balance when trends indicate fund balance will fall outside the minimum/maximum levels in compliance with Government Accounting Standards Board (GASB) Statement No. 54.

### Page # 2: Arenac County Commissioner's Minutes of November 15, 2011:

### **Policy**

Fund Balance is created from excess revenues over expenditures. It is a fund's net assets, mostly made up of cash and investments and, unless otherwise restricted, available for spending. There are five components of fund balance:

- 1. Non-spendable Fund Balance. This portion of fund balance is *non-spendable* because of its form, for example inventory and non-financial assets, or because of legal or contractual requirements.
- 2. Restricted Fund Balance. This portion of fund balance is restricted due to external limitations placed on the use of the funds. The restriction typically comes from outside the local government as a condition of the revenue source.
- 3. Committed Fund Balance. Fund balance is *committed* if a limitation is set in place by formal action of the County Board prior to the end of the fiscal year. The limitation remains binding until the County Board takes formal action to remove it.
- 4. Assigned Fund Balance. Fund balance may be assigned to reflect the intended use of the resource. The assignment of funds may come from the County Board or from the County Treasurer. Less formality is needed to impose, remove, or modify a constraint reflected in Assigned Fund Balance. No funds other than the General Fund may have Unassigned Fund Balance, therefore any amounts remaining in excess of Non-spendable, Restricted, or Committed funds in funds other than the General Fund will be reported as Assigned Fund Balance.
- 5. Unassigned Fund Balance. The General Fund, and no other governmental fund, may have resources that cannot be classified in one of the first four categories described above. Only the General Fund can report a surplus, an *Unassigned Fund Balance*.

Because Non-spendable and Restricted fund balance are not available for spending due to external enforceable conditions this fund balance policy is focused on the appropriate level of General Fund and Unrestricted fund balances, those classified as Committed, Assigned, and Unassigned.

Financial Flexibility, provided by adequate fund balance, is needed to cushion the impact of unanticipated emergencies and revenue shortfalls. These include loss of major taxpayers, loss of state revenue sharing, infrastructure emergencies and other economic distresses that serve to impair the City's ability to deliver essential community services. Without this cushion, taxpayers would be subject to millage increases, cuts in services, and/or deferred investment in and maintenance of infrastructure.

### Fund Balance "Spending" Prioritization

As required by GASB 54, the Arenac County Board of Commissioners hereby establishes that the County's policy shall be that when multiple classifications are available and appropriate for particular expenditures, the most restrictive category of Fund Balance will be used first working toward unassigned fund balance. Relative restrictiveness of Fund Balance shall proceed from most to least in order of the five classifications listed in this policy.

### Minimum/Maximum Fund Balances

The minimum/maximum range will be determined each year and reported as part of the fiscal year budget.

# <u>December 28, 2011</u> <u>Budget Hearing and Special Session</u> Arenac County Board of County Commissioners

Chair Michael Snyder called the meeting to order at 10:08 A. M. pursuant to the motion from the December 20<sup>th</sup>, 2011 meeting adjournment as a Budget Hearing and Special Session. The Board opened the meeting with the recitation of the Pledge of Allegiance to the U. S. Flag as further pursuant to public notice and the Michigan Open Meetings Act.

Present: Commissioners Jeffrey Trombley, Joseph Sancimino, Michael Snyder, Virginia Zygiel, & Robert Luce.

### Adoption of an Agenda:

It was moved by Mrs. Zygiel & 2<sup>nd</sup> by Mr. Luce to approve the proposed agenda with additional motions being added to: #4: Pay the Book of Bills. #5: Approve Minutes of December 20<sup>th</sup>, 2011. It was also agreed that the Board would discuss possible reorganization dates and times with the County Clerk. Motion carried.

### The Chair declared the 2012 All Funds Budget Hearing Open for Public Comments and Review:

Undersheriff Donald McIntyre was in attendance to answer certain questions raised by Commissioners. Certain budget line items were adjusted at that time. Budget 266 Road Patrol was adjusted including movement of \$39,000 between line items. The Board and the Undersheriff further discussed the status of other budgets including "Stone Garden" and the STING Program as well as noting the proposed budget document reduces any fund balance in the Road Patrol by the end of 2012. The County Treasurer noted that there will be a balance in the account due to revenues from Sting Court Assessments.


